


**ORDER: SPREAD ON THE MINUTES BONDS FOR JAMIE ROSE,

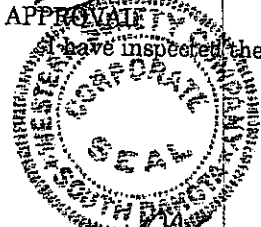

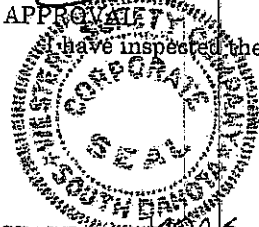

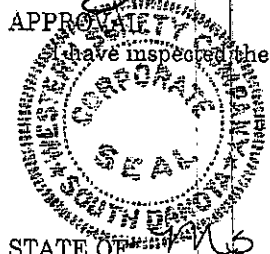
