


**ORDER: AUTHORIZE TRAVEL FOR JUSTICE COURT CLERKS,

Dear MJCCA members:

The MJCCA Annual Convention will be held in *Natchez, MS*. The dates will be *September 4-6, 2019*.

Reservations can be made at the Magnolia Bluffs Casino & Hotel. A total of 80 rooms at the price of \$89.00 per night have been reserved just for us. The Holiday Inn has reserved 20 rooms at the price of \$89.00 for the remaining. Please make your reservations early, so you don't miss out on the special block.

**Reservation Procedure – Individual call-In:** Attendees should call Magnolia Bluffs Casino & Hotel directly at (601)861-4600 or (601)442-4462, for Holiday Inn Express & Suites and identify themselves as part of the **MS Justice Court Clerks Association** to receive the special room rate. **Reservations should be made by August 4, 2019.** Any reservation request received after this cutoff date will be honored on a space available basis at the regular hotel rate. Please bring a copy of your county's tax exempt certificate and it must be presented at the time of check in. The tax exempt is only good for sales tax not tourist tax, at a 10% of sleeping rooms and \$2.00 per night for city room occupancy charge.

If you are paying with your **county check** please inform the hotel in advance and get total price of your stay. Please make sure the check reaches the designated place fourteen (14) days prior to arriving. Magnolia Bluffs Casino & Hotel, 645 S. Canal Street, Natchez, MS 39120 or Holiday Inn Express & Suites 639 S. Canal Street, Natchez, MS 39120.

**Check-in & Check-out:** Check-in time is 3:00 p.m. and check-out time is 11:00 a.m. The hotel will make every effort to accommodate early arrivals and late departures. Requests will be handled on individual basis and will depend upon the hotel's availability
