Preservation and Maintenance Covenant

WHEREAS, the title to the property knowns as Lafayette County Courthouse, located in Lafayette County MS, is vested in us, hereinafter referred to as the "Owner"; and

WHEREAS, the Lafayette County Courthouse, which is particularly described as follows:

LAFAYETTE COUNTY COURTHOUSE, located in the Southeast ¼ quarter of the Southwest quarter of Section 21, Township 8 South, Range 3 West, Oxford, Mississippi

Hereinafter referred as the "property"; and

WHEREAS, upon applying for a Community Heritage Preservation Grant, the Owner understood the requirement that the property be designated a Mississippi Landmark; and

WHEREAS, the Owner understood that designation to be a perpetual preservation easement on the property; and

WHEREAS, the Owner understands that as a result of Mississippi Landmark designation, the property cannot be altered, destroyed, or impaired without a permit from the Board of Trustees of the Mississippi Department of Archives and History, regardless if the work is done with state funds or not; and

WHEREAS, the Owner agrees to abide by the regulations of the Mississippi Landmark program and to contact the Department of Archives and History in the early planning stages of all projects that will affect the property, whether they are funded by grants from the Department of Archives and History or not; and

WHEREAS, Lafayette County Courthouse will be restored with funds made available to the Owner through a Community Heritage Preservation Grant administered by the Mississippi Department of Archives and History; and

WHEREAS, as a condition of the receipt of such funds, the Owner has agreed to encumber the property with certain covenants and restrictions; and

WHEREAS, the Owner understands that if the building is abandoned, neglected, or not well maintained in a good state of repair prior to the expiration of the covenant period, MDAH may take steps to recover the grant award in part of in full.

NOW, THEREFORE, it is hereby declared that the following covenant will be placed on the property, in addition to the Mississippi Landmark designation, for the purpose of protecting and preserving the architectural and historical integrity of the property, as well as the State of Mississippi's investment in the property. The following covenant shall be binding upon any and all parties having any right, title or interest in or to the property or any part hereof:

The Owner agrees and hereby binds itself and all successors in title and interest, to maintain the property in a good state of repair for a period of twenty-five (25) years from the grant award date.
