


ORDER: AUTHORIZE SOLID WASTE ADJUSTMENTS FOR MARCH 2024

Motion was made by John Morgan, duly seconded by Greg Bynum, to authorize Solid Waste adjustments for March 2024.


The vote on the motion was as follows:
