# **AGREEMENT**

This Agreement made and entered into this date by and between Three Rivers Planning & Development
District (Three Rivers), a Mississippi non-profit corporation domiciled in Pontotoc, Pontotoc County
Mississippi and Locaye Le County, Mississippi (County), a political subdivision under
the laws of the State of Mississippi.

Whereas, Three Rivers provides computer support and IT assistance to County on an on-going basis; and

Whereas County has certain computer servers that are outdated and/or obsolete and need support or replacement; and

Whereas Three Rivers is desirous of assisting County in replacing or updating those servers for the County; and

Whereas Three Rivers and County now desire to reduce their Agreement to writing.

NOW THEREFORE, FOR AND IN CONSIDERATION OF ONE (\$1.00) DOLLAR and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto do now agree and covenant as follows:

(1)

The County currently has a "host" server that needs to be replaced; further, the host server houses two critical servers. There is a domain controller (DC). This DC authenticates log-ins to all computers on the local network as well as securing data shared on the file server. Services such as DHCP and DNS are also installed on the DC. These services are vital to the ability of individual computers on the network to connect to other computers as well as the internet. The second server is the file server that houses data shared between users on the domain. The file server also plays an important role in data backup by consolidating the County's important files and documents into one location.

(2)

Three Rivers has identified that County needs the following server upgrades for its specific quantity of computers, storage, memory, etc., to wit:

Replace Current Host/Server with Dell Poweredge Server, 64GB memory, 4TB Storage, 5-year pro support on-site manufacturer warranty, upgrade all OS to Windows Server 2022 Datacenter Version.

(3)

That Three Rivers shall acquire at least two (2) competitive quotes for the above needed servers and related equipment for County to procure said servers/equipment.

That Three Rivers shall install the servers and equipment for an additional fee of \$750.00.

The County can elect to purchase the servers and related equipment, plus the installation fee to be paid to Three Rivers. The installation fee shall be paid by County to Three Rivers within thirty (30) days of installation.

Alternatively, Three Rivers shall provide financing for the purchase of the servers/equipment if the County requests it to do so. The financing package shall be for five (5) years at 4% per annum with equal annual payments due on October 15 of each year until paid in full.

The quotes obtained by Three Rivers for use by the County in purchasing the servers/equipment shall include a minimum warranty of five (5) years.

That this Agreement shall be governed by the laws of the State of Mississippi.


