## AMENDMENT #2 TO THE FOOD SERVICE AGREEMENT

This Amendment is made and entered into by and between Lafayette County Detention Center ("Client"), and Summit Food Service, LLC ("Company") (collectively "the Parties").

WHEREAS, the Parties have entered into a certain FOOD SERVICE AGREEMENT (the "Agreement"), effective August 1, 2022;

WHEREAS, the Parties have agreed to extend the Agreement with a pricing adjustment; and WHEREAS, the Parties now desire to amend said Agreement upon the terms and conditions stated herein.

NOW, THEREFORE, the Parties, intending to be legally bound hereby, mutually agree as follows:

- Term. This Agreement shall be extended for an additional year beginning August 1, 2024. Per section 1.2 of the Agreement, the term shall automatically renew for additional one-year periods thereafter unless terminated per the Agreement.
- 2. <u>Payment Arrangement.</u> Per section 7.5 of the Agreement, pricing at section 7.1.A. shall be amended to reflect that Company shall charge per the following scale:

This Amendment is effective as of August 1, 2024. All other terms and conditions of the original Agreement (as modified from time to time) shall remain in full force and effect unless otherwise amended as provided in the Agreement.
